
This report is submitted in compliance with K.S.A. 5-506(b), which mandates the director of dispute resolution to report annually on the implementation of the Kansas Dispute Resolution Act. The act establishes an approval process for individuals and programs that practice dispute resolution, which is defined as "a process by which the parties involved in a dispute voluntarily agree or are referred or ordered by a court to enter into discussion and negotiation with the assistance of a neutral person." Common forms of dispute resolution used in Kansas include mediation, conciliation, and parenting coordination. The act also establishes the Advisory Council on Dispute Resolution composed of knowledgeable individuals trained in dispute resolution. The council advises the director of dispute resolution on administering the act and related topics.

In this report, you will find information on the types of disputes handled by approved individuals and programs, suggestions for program development, statistics concerning the number and resolution of disputes, and other information relevant to achieving the goals of the Kansas Dispute Resolution Act.

### **Key Highlights**

It has been a productive year for the director of dispute resolution and the Advisory Council on Dispute Resolution. We report these key initiatives and achievements.

#### **&** Brochure about mediation

Together, the director and council created a <u>brochure about mediation</u> to inform the public about services in Kansas. They distributed the brochure to Kansas self-help centers and posted it on the judicial branch website.

#### Mediation videos

The council produced videos to answer the most common questions about mediation. They are posted on the <u>Mediation Most Frequently Asked Questions</u> webpage on the judicial branch website.

- Is mediation the right choice for me?
- Is mediation voluntary, confidential, and safe?
- How much does mediation cost, and how long will it take?
- What do I look for when choosing a mediator?
- How does mediation work?
- How do I prepare for mediation?

#### Roundtables

The director hosts roundtables for domestic court services officers. Domestic CSOs help courts manage domestic caseloads more efficiently by providing <u>mediation</u>, <u>conciliation</u>, and <u>parenting coordination</u>.

#### Newsletter

The director publishes a <u>quarterly newsletter</u> for approved providers and programs. The newsletter keeps the reader up to date on alternative dispute resolution in Kansas.

#### **\*** Rule amendments

The council began a comprehensive review of current <u>Rules Relating to Dispute Resolution</u>. Potential revisions are being discussed, and the council is exploring including new types of alternative dispute resolution methods in the rules.

#### **❖ Virtual Dispute Resolution Town Hall**

The director holds an annual town hall meeting for approved providers and programs. This interactive event allows attendees to engage directly with the director.
